

Department of Housing, Local Government and Heritage Monthly Homelessness Report July 2021

Note on July 2021 Monthly Homelessness Report and upgrade of the system for recording and reporting homelessness data

Homeless monthly reports are collated on a regional basis and are based on data provided by housing authorities and produced through the Pathway Accommodation & Support System (PASS).

PASS is the live shared emergency bed management and client support tool for people experiencing homelessness in Ireland managed by the National PASS Office in the Dublin Region Homeless Executive (DRHE). An upgrade of the system has taken effect from July 2021 onwards, which was noted on the publication of the Homelessness Report for June 2021, which was published on 30 July 2021.

One effect of this change is to allow for the accurate identification of the numbers of children within homeless families, which are now being reported for the first time in the July 2021 report. Up to this point the monthly reports enumerated the number of individuals accessing homeless services broken down by adults and dependants. This resulted in a number of adults being listed among these dependants, most frequently in the case of children over 18 being associated with a homeless household, but also other adult family members.

Notwithstanding this, the dependants figure was widely used as a proxy for the number of children in emergency accommodation. The upgrade of the recording and reporting system has allowed for the reporting of the number of persons under 18 years of age within homeless families in emergency accommodation. From the July report onwards, the term 'dependant' has been replaced by 'child dependant'. All those over 18 years of age in families continue to be counted in the family homelessness statistics, and are counted as adults.

The Monthly Homeless Report includes information on the number of families who are in emergency accommodation. The number of single parent families has also been reported from within this group. As the changes to the new system are being implemented, the data for single parent families has not been included in the table for July 2021. This data for single parent families will be included in all future reports.

The changes to the Pathway Accommodation & Support System will also allow for additional data to be reported in the Homeless Progress Report, which is published quarterly by the Department. The quarterly reports include details of the numbers of individuals exiting homelessness into tenancies and the duration of stay in emergency accommodation. A greater level of detail will now be capable of being produced for these data. The change to the new system will also enable the recording of the numbers of households in emergency accommodation in addition to the number of individuals, as is the case currently. The next quarterly report is due for publication on 29 October 2021.



Homeless statistics and regional structures

The Department's official homelessness statistics are published on a monthly basis and refer to the number of homeless persons accommodated in emergency accommodation funded and overseen by housing authorities during a specific count week, typically the last full week of the month. The reports are produced through the Pathway Accommodation & Support System (PASS), collated on a regional basis and compiled and published by the Department. Homelessness reporting commenced in this format in 2014.

Monthly homelessness data are published to www.housing.gov.ie on the last working Friday of every month. These data are also available in open format on www.data.gov.ie and are made available under the CC BY 4.0 License, and are available for reproduction elsewhere, subject to appropriate credit being given to the Department of Housing, Local Government and Heritage.

The administration of homeless services is organised across nine administrative regions, with one local authority in each of the regions, "the lead authority", having overall responsibility for the disbursement of Exchequer funding. In each region a Joint Homelessness Consultative Forum exists which includes representation from the relevant State and non-governmental organisations involved in the delivery of homeless services in a particular region. Delegated arrangements are governed by an annually agreed protocol between the Department and the lead authority in each region. These protocols set out the arrangements, responsibilities and financial/performance data reporting requirements for the delegation of funding from the Department.

Under Sections 38 and 39 of the Housing (Miscellaneous Provisions) Act 2009 a statutory Management Group exists for each regional forum. This is comprised of representatives from the relevant housing authorities and the Health Service Executive, and it is the responsibility of the Management Group to consider issues around the need for homeless services and to plan for the implementation, funding and co-ordination of such services.

Glossary:

- PEA Private Emergency Accommodation: this may include hotels, B&Bs and other residential facilities that are used on an emergency basis. Supports are provided to services users on a visiting supports basis.
- STA Supported Temporary Accommodation: accommodation, including family hubs, hostels, with onsite professional support.

TEA - Temporary Emergency Accommodation: emergency accommodation with no (or minimal) support
